#### MOBILE TRADE STAND INFORMATION SHEET TRADERS VILLAGE OR GRADE 1 AREA WORLD PIPE BAND CHAMPIONSHIPS 2025

#### **EVENT INFORMATION**

For the past seven decades, Glasgow has been a global meeting place for pipe band competitions. Every year over 8,000 of the world's best pipers and drummers and an audience of up to 30,000 assemble for the World Pipe Band Championships. Glasgow will once again host this exciting event in 2025, the largest of its kind in the world. The Championships, which will take place over two days, and feature a Scottish Food & Trader Village. The event is covered by the BBC on television, radio and on-line with live web streaming around the globe.

The Grade 1 qualifiers and the inaugural World Youth Championship will be held on Friday 15<sup>th</sup> and will take place from <u>0900hrs – 1730hrs</u> with up to 8,000 people expected to attend. <u>Mobile Trade Stands within the Premium (Grade 1) Area must</u> <u>take part on both Friday 15<sup>th</sup> and Saturday 16<sup>th</sup> August. Mobile Traders within the</u> <u>Traders Village will not operate on Friday 16<sup>th</sup>.</u> On Friday 15<sup>th</sup> August the site will be open from 0800hrs – 1800hrs.

On <u>Saturday 16<sup>th</sup> August</u>, the full site will be in operation from <u>0700hrs – 1900hrs</u> with an expected audience of up to 30,000 to attend on the day. Competition will start at 0900hrs.

### **ARRIVAL AND OPERATING TIMES**

Please select when you will first arrive on your application form. The park will be secured overnight by SGL security personnel if you wish to fully set up your area the evening before the event.

No Mobile Traders will be permitted to enter the site out with the times stated. All Mobile Traders **MUST** be ready for inspection one hour before opening, i.e., by **0700hrs on Friday and 0600hrs on Saturday** 

Mobile Traders should not start to dismantle their units before the official end of the event (approximately 1730hrs on Friday and after the conclusion of the Prize Giving, approximately 1830hrs on Saturday). You will be informed when this can happen by the Event Organisers. Traders will be afforded **no vehicle movement** until an announcement lifting the curfew has been made by the Event Organisers. We expect this to be around 1800hrs on Friday 2000hrs on Saturday.

There will be a large number of Traders onsite at the World Pipe Band Championships therefore no Trader holds exclusive rights for the sale of any product. Event organisers will work to minimise similar vendors being pitched beside one another to allow for optimum trading opportunities.

# PASSES FOR ALL MOBILE TRADERS

Traders will be allocated 3 Trader Passes per stand. Additional Trader Passes are available at a cost of £8 each. Please indicate on your application how many additional Trader Passes you require.

# CAR PARKING FOR ALL MOBILE TRADERS

One Trader car par pass will be allocated to each stand for the Traders Car Park. All vehicles must be parked in the Traders Car Park by **0700hrs** on both mornings of the Event. There will be no parking adjacent to your trade stand and no overnight parking is available.

- 3. All electrical appliances must be PAT (Portable Appliance Test) certificated. Certificates should be visible for inspection.
- 4. Please note stock cannot be fixed to the covered structure; however, items can be displayed in free standing equipment provided by the Trader within their designated trading area
- 5. Please Note: No organisation may raise funds by way of charitable collections
- 6. Please Note: Due to the nature of our licence, no organisation may sell

alcohol

- 7. Please keep a copy of your application form for your records.
- 8. The Event Organisers reserve the right to refuse any application
